## **Christmas Tree Lot Update**

Optimists,

The first draft of the tree lot schedule was sent last week. I know it is difficult to think of Christmas when Halloween awaits, however, we need to begin. Thank you to those who have already generously provided dates and times. The schedule will go out once a week with updates. Please remember to look at your calendar and let me know what works for you.

It is going to be an interesting season. Not only do we have a new location but trees are scarce this year. Trees that are 8' to 9' (white tag) are in very short supply. We are only getting 45 when we usually get 150. We usually order 2450 trees. This year we are only getting a little over 1700.

Why the low supply? According to our grower, 2008, many tree farms went

out of business due to the recession. Also, the older tree farmers retired and there was no one in the family who was interested in continuing. Many tree farms folded.

Then, in 2015, demand for trees increased due to studies citing that real trees were better for the environment. Fresh Christmas tree demand continues to increase every year, particularly for taller trees as home building includes more open spaces and taller ceilings. It takes about a year for a tree to grow a foot. Presently, tree farmers are having difficulties in finding saplings as they too are now in short supply. And, I understand that saplings these days are very expensive making a tree farm business model not as profitable. Growers have acquired more land but they have yet to plant. I hope you can see how this is all interconnected.

If demand for trees continues to increase, it will still take a few years to work out of this. It seems like a good/bad type of problem. I think this year is the ultimate bad problem, especially with the cost of diesel fuel ticking upward.

However, we are Optimists. We will have a good year!!! Actually, we are very fortunate! It was wonderful to have found a new location where we are wanted and welcomed. A big thank you to the Knights of Columbus who reached out to us!!!
